# **Any Other Business**

We will be applying for funding to purchase rose bushes for Twyn Yr Hydd. Hopefully, once completed, we hope to apply for funding to purchase additional two-way radios which are essential now that we are operating from both the Turbine House and Courtyard Room. It has been agreed that any volunteer working alone must carry a two-way radio.

We are also looking into funding to purchase new all-terrain mobility scooters, at a cost of £15,000. It has been mentioned to park management who are happy for us to go ahead with this project.

The activities team have had a busy summer providing free themed crafts and activities and have raised £686 in donations. The next activities meeting is planned for a weeks' time where planning for Halloween and Christmas will be discussed.

TB stated that during the recent Dinosaur Event our volunteers received a total of eighty-five complaints regarding the lack of a cash point or cash back in the park. It was agreed that this would be raised at the next park management liaison meeting which we hope will be in the next week or so. We have also received complaints regarding the lack of dog bins which will also be raised.

TB brought the meeting to a close and once again thanked all guests and members for attending.
